## **RESOLUTION NO. 13-**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAUDERDALE, FORT FLORIDA, **AUTHORIZING** ACCEPTANCE OF GRANTS FUNDS IN THE AMOUNT OF FROM THE SOUTH FLORIDA \$564.841 REGIONAL TRANSPORTATION AUTHORITY FOR THE SUN TROLLEY COMMUNITY BUS SERVICE; AND AUTHORIZING THE OFFICIALS PROPER CITY EXECUTE TO GRANT AGREEMENTS NECESSARY TO ACCEPT SUCH GRANT FUNDING.

WHEREAS, on January 22, 2013, the City Commission approved the application to the SFRTA for mobility, management, consultant and operating costs for the downtown Fort Lauderdale TMA; and

WHEREAS, the City of Fort Lauderdale was awarded the Federal Transportation Administration New Freedom Grants through South Florida Regional Transportation Authority for operation costs of \$356,841 and capital costs of \$208,000 for mobility management consultant for the community bus service; and

WHEREAS, the Grant requires a 20% soft match and 50% operating costs of \$304,841 to be provided by the TMA; and

WHEREAS, this is a reimbursable grant and the City of Fort Lauderdale will reimburse the eligible TMA expenses as outlined in the existing agreement between the City and the TMA; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the proper City officials are hereby authorized to accept grant funds from the South Florida Regional Transportation Authority in the amount of \$564,841 total for two years for the Sun Trolley Community Bus Service.

<u>SECTION 2</u>. That the proper City officials are hereby authorized to execute agreements with the South Florida Regional Transportation Authority to accept grant funds in the amount of \$564,841 total for two years for the Sun Trolley Community Bus Service.

<u>SECTION 3</u>. That the office of the City Attorney shall review and approve as to form all documents prior to their execution by proper City Officials.
