**TITLE**: Motion to award a one-year contract for noise abatement consultant

services – Request for Proposal (RFP) 545-11443 - \$49,450

#### Recommendation

It is recommended that the City Commission award a one-year contract for the purchase of noise abatement consultant services to Harris Miller Miller & Hanson, Inc., utilizing the City's Contract (Form P-0001), in the estimated annual amount of \$49,450 and authorize the City Manager to approve up to three, one-year renewal options.

### **Background**

The City of Fort Lauderdale has worked for years with the community to reduce noise from turbojet aircraft and is committed to continually develop ways to reduce aircraft noise. The Fort Lauderdale Executive Airport Division continues that effort with a comprehensive Noise Compatibility Program (NCP) that relies upon a partnership between the community, airport users, and City staff. The NCP was established through extensive public involvement to minimize aircraft noise over neighboring communities. A large element of the NCP is monitoring airport activity and industry trends to better address noise concerns. This is accomplished through evaluating, guiding, and updating components of the program requiring highly specialized experts in airport noise.

The background of the solicitation process includes the following:

- June 3, 2014 An RFP was issued for noise abatement consultant services.
- July 1, 2014 The RFP closed with a total of two firms submitting proposals in response to the RFP. The two firms are:

Harris Miller Miller & Hanson, Inc. (HMMH) Landrum & Brown, Incorporated (L&B)  July 28, 2014 – The evaluation committee consisting of Florence Straugh, Noise Abatement Officer; Fernando Blanco, Airport Engineer; and Scott Kohut, Airport Operations Supervisor evaluated and ranked the two proposals according to the evaluation criteria, as shown in the table below.

From the proposals submitted, both firms showed that they were highly experienced in the field of airport noise and related airport work. The committee noted that the HMMH team had extensive experience with general aviation airports and other significant work experience in Florida and around the country. The committee also recognized HMMH's thorough understanding of the Airport's NCP history and relevant program needs that were reflected in the committee's collective points.
