Recommendation

It is recommended that the City Commission approve Task Order No. 4 to Miller Legg & Associates, Inc. in an amount not to exceed \$18,130 to complete an environmental feasibility study to evaluate an expansion of the Las Olas Marina (P-11671).

Background

The City has received a proposal for development and expansion of the Las Olas Marina. A proposed marina expansion would consider a reconfiguration of the existing Las Olas Marina, including deepening of the marina basin to the proposed Intracoastal Waterway (ICWW) depth, reconfiguration and replacement of the marina docks, and expansion of the marina limits further east.

The Florida Inland Navigation District (FIND) plans to deepen the ICWW in the vicinity of the Las Olas Marina. The City is currently evaluating dredging the ICWW bottom, extending from the eastern limit of the FIND ICWW dredging, to the face of the docks at the Las Olas Marina. A City conceptual mitigation plan considers seagrass mitigation associated with the dredging and does not address any potential mitigation associated with the proposed marina expansion. A feasibility study is needed to evaluate the environmental considerations and regulatory requirements associated with a proposed Las Olas Marina expansion.

To complete the environmental feasibility study and prepare a written report, a task order needs to be issued to Miller Legg and Associates, Inc. The purpose of the task order is to determine environmental permitting and constraints as it relates to expanding the marina further east into uplands.

Resource Impact

There will be a fiscal impact to the City in the amount of \$18,130.
