TITLE:	Motion to approve proprietary purchases of software/hardware maintenance renewals - \$302,893

Recommendation

It is recommended that the City Commission approve the proprietary purchase of software/hardware maintenance renewals from Periscope Holdings, Inc., Cogsdale Corporation, and Environmental Systems Research Institute Incorporated (ESRI) in the total amount of \$302,893.

Background

The Information Technology Services Department has proprietary maintenance software/hardware support requirements of various computer software systems.

The renewal for BuySpeed On-Line (BSO) from Periscope Holdings, Inc. is \$26,015. This software is used for processing all purchase orders for goods and services. It allows the orders to be electronically integrated into the City's general ledger system. Periscope Holdings, Inc. is the sole provider of support for the BSO software system.

The renewal of the Financial Accounting Management Information System (FAMIS) and Budget Preparation (BPREP) Software from Cogsdale Corporation is \$213,043. This software is used for financial accounting and budget preparation. There are over 500 users throughout the City who access this system and have numerous interfaces from other computer systems. Cogsdale Corporation is the sole provider of support for the FAMIS/BPREP software system.

The renewal of Geographic Information Systems (GIS) Software from ESRI is \$63,835. The software is the foundation for GIS applications. The Information Technology Services (ITS) Department uses this software for the support and maintenance of various systems which rely heavily on map data. Annual maintenance is required to receive new upgrades and technical assistance/support for all software related questions and/or problems. ESRI is the sole provider of updates, maintenance and support.

Resource Impact

There will be a fiscal impact to the City in the amount of \$302,893.
