IF A SPEAKER HAS ALREADY SPOKEN THE PREVIOUS MONTH AND MORE THAN FIVE (5) APPLICATIONS ARE RECEIVED, THEN SUCH SPEAKER WILL BE SCHEDULED FOR THE FOLLOWING MONTH IN ORDER TO GIVE NEW SPEAKERS THE OPPORTUNITY TO BE HEARD.

- This document may be a public record under Florida law, which defines "public records" to mean, all
 documents, papers, letters, maps, books, tapes, photographs, films, sound recordings, data processing
 software, or other material, regardless of the physical form, characteristics, or means of transmission, made

 agency.
