## **Recommendation**

It is recommended that the City Commission authorize the execution of a Lease Agreement for police use.

## **Background**

The City's contracted real estate service, Commercial Real Estate Services (CBRE), has obtained a quote for a leased facility designed to house approximately twenty-six (26) personnel.

The following table is reflective of the proposed lease.

Rent and triple net charges will commence on the later of April 1, 2015 or upon receipt of a Certificate of Occupancy and completion of Landlord's Work. The cost for the first year lease will be \$48,546. Estimated utility cost will be \$1.50/rsf. There will also be an IT remote location setup charge of approximately \$20,000 - \$30,000.

CBRE, the City's Real Estate Advisor, reports that comparable properties receive \$19 - 26/ rsf base rent inclusive of operating expenses and real estate taxes.
