NCL Board Member Job Description

- 1. Attends a minimum of one board meeting in person or by telephone. There are three board meetings per year: February, June and November. Usually two meetings (Feb. and June) are by telephone conference call.
- 2. Serves on a board committee. There are three board committees: Nominations, Finance or Program.
- 3. Is an ambassador for NCL by participating in NCL programs and speaking about NCL in settings that may be helpful to the organization.
- 4. Seeks to develop supportive relationships for NCL, including identifying and nurturing potential new board members.
- 5. Makes an annual contribution to NCL that demonstrates that NCL is one of their top nonprofit commitments. In addition, Board members pay for their own travel to and lodging at board meetings.
- 6. Participates in fund raising by identifying and nurturing potential funders and members.
- 7. Is an active participant in the board and committee's evaluation and planning efforts.

National Civic League - Strategic Plan for 2014-2019

Summary

NCL's Vision: NCL envisions a country in which all people engage in the process of self-governance and encourages cross-sector partnerships resulting in an active civic culture reflecting the diversity of community voices.

NCL's Programs and Services Strategies, Action Items, and Timelines Changes noted in bold – as of Jan/Feb 2014

Government and Governance

- a. Fostering innovation in improving and increasing the ability of all people to contribute to, participate in, and benefit from civic life.
 - Action Item: By Dec 2014, link research & All-America City Awards and make the findings and community promising practices available to members in an online database.
 - ii. Action Item: By March 2015, implement a monthly a conference call/webinar series on AAC and NCL research for members and AAC finalists and winners. The objective is to lift up the NCL family as an important source of information on innovation.
- b. Keeping current key governance publications, for example the 8th Edition of the *Model City Charter*.
 - Action Item: Produce 3rd Printing of 8th Edition of *Model City Charter* in 2014 to include fiscal sustainability research. <u>First quarter 2014. changed to</u>
 First quarter 2015
 - ii. Action Item: Produce 9th Edition of the *Model City Charter* by 2017. Develop plan by Dec 2014 (be sure to include social media/online issues). Secure funding in 2015. Establish Advisors and revise in 2016. Release (online and in print) by 2017.
 - iii. Action Item: By Dec 2015, consider value of updating and producing online versions of *Model County Charter* and other publications. Develop recommendation and/or plan for ongoing modernization of NCL governance publications for consideration by NCL Board Program Committee.
- c. Conducting research on key governance issues, such as fiscal sustainability, and incorporating the research into NCL's century-old, award-winning journal, *National Civic Review* and into stand-alone publications as well as distribution through other means.
 - *i.* Action item: By Summer 2014, publish special edition of *National Civic Review* featuring California Fiscal Sustainability Cases and insights
 - ii. Action Item: By Sept. 2014, identify and pursue national Fiscal Sustainability funding (in partnership with USC and USF) to continue this research.
 - *iii.* Action item: By March 2014, identify at least one governance issue NCR should feature and potential funders.
 - *iv.* Action item: By Summer 2014, complete 2 healthy community special editions of NCR, with the support of Kaiser Permanente. Consider other health-related NCR issues for 2015 and 2016.

Citizen Engagement

- d. Making youth civic engagement a key component of NCL's work through research, outreach, training, fellowships, and a spotlight at the All-America City Awards.
 - Action Item: By January 2014, develop a multi-year NCL Youth Civic Engagement Program and seek out funding for implementation in Fall 2014 and beyond.

 - i. Action Item: Ongoing, work with ICMA (International City/County Management Association) to work with its members to engage its residents.

 - Action Item: <u>By September 2014 (COMPLETED)</u>, complete and release an updated and online (2015) new *Civic Index* and conduct training and technical assistance to ICMA, National League of Cities and NCL members. Consider a partnership with NCOC and their *Civic Health Index* work.
- h. Connecting communities involved in civic renewal through social media and inperson exchanges to learn from and support each other.
 - i. Action Item: By Spring 2014, develop a robust plan of connecting communities via a peer learning network (See AAC below).

Civic Recognition Awards

- Providing a unique, transformative experience for people of all walks of life, including youth, through the original civic and community award, the All-America City Awards.
 - i. Action Item: By June 2014, conduct AAC spotlighting healthy communities with 20 finalists, more than 400 participants, and ten winners. Conduct monthly conference calls (engaging approximately 100 communities) featuring past winners and health experts for prospective applicants. Obtain more than 60% good to excellent participant ratings of the awards event. Obtain \$150,000-\$200,000 in sponsorship support.
 - ii. Action Item: By June 2015 & 2016, conduct AAC in partnership with the Campaign for Grade Level Reading engaging more than 100 GLR communities.
 - iii. Action item: By Spring 2014, develop an AAC Peer Network Program to continue the learning that takes place at AAC.
 - iv. Action Item: By June 2014, develop and put into place an AAC logo use policy that provides annual funds to NCL for the AAC logo use beyond the winning year.
 - v. Action Item: By September 2014, develop and trademark and begin to <u>use</u> a revised AAC logo that incorporates National Civic League into the "shield" with the intent of increasing NCL's visibility as the home of the AAC.
- Accelerating the development of networks centering on a specific issue (ex. thirdgrade reading).
 - i. Action Item: Ongoing, seek out other issues and networks in development that AAC could help jumpstart.
