**TITLE:** Annual Facility Use Agreement with the City of Hollywood for Fire Training  
- \$25,000

**Recommendation**

It is recommended that the City Commission approve a motion authorizing execution of a facility use agreement between the City of Fort Lauderdale and the City of Hollywood for Fire Rescue Department training purposes and to authorize the City Manager to approve a one year renewal option.

**Background**

Fort Lauderdale Fire Rescue has utilized the Hollywood Fire Rescue Training Academy for the past two years for Fire-Rescue training activities. This new agreement would allow for the City of Fort Lauderdale to continue using the Hollywood training academy in accordance with the fee schedule set forth in Exhibit A of the Agreement. The term of this agreement begins on February 18, 2015 and ends on February 17, 2016 and may be renewed for an additional one year upon agreement of the parties.

**Resource Impact**

There will be an annual fiscal impact to the City in the amount of \$25,000. Future expenditures are contingent upon approval and appropriation of the annual budget.
