TITLE: Annual Storm Drainage Contract Extension – GPE Engineering & General

Contractor Corp. - \$1,325,000

Recommendation

It is recommended that the City Commission approve a one-year contract extension for the Annual Storm Drainage Contract with GPE Engineering & General Contractor Corp. (GPE).

Background

On January 8, 2013 (CAM 12-2514) the City Commission approved a two-year unit price contract for annual stormwater construction services (Bid No. 623-11048, Project 11780) with GPE. This annual contract allows for three one-year extensions contingent upon mutual agreement and funding availability. The pricing in the existing contract is favorable to the City, therefore extending the contract at this time rather than rebidding a new contract is desirable.

Resource Impact

There will be a fiscal impact to the City in the amount of \$1,325,000.
