Dennis Ulmer read from a prepared statement, which is attached to these minutes.

**CIT-3 14-1480**      CHERYL WHITFIELD - ADA Access to Beach, Water and Sand on Fort Lauderdale Beach

Cheryl Whitfield noted that there was an armed carjacker in her neighborhood this morning and thanked police for keeping the citizens safe. She noted that Azul Airlines launched its first flight from Sao Paulo to Fort Lauderdale and commended the City for being the first in the United States to receive that honor. She thanked the Commission for welcoming the Brazilian community and advocated for an exchange program between City staff and staff of a Brazilian city such as Sao Paulo or Curitiba. She suggested that people with wheelchairs and walkers should be able to access the beach. She felt design changes should be made to the A1A construction project currently underway to accommodate the handicapped, i.e. cutout of the wave wall.

**CIT-1 14-1478**      ART SEITZ - Fort Lauderdale Beach

Art Seitz criticized the news coverage and follow-up of the *Sun-Sentinel*. Fort Lauderdale voted to construct an A1A greenway. The County contributed funds for conceptual drawings. If the City had been shovel ready when federal funds became available, perhaps the project could have gone forward and safety would be improved. He questioned the Commission's intent with respect to public parking on the beach. He suggested issuing a request for proposals for the Las Olas Marina.

**CIT-2 14-1479**      MATT HABIBI, ESQUIRE - Mitigation of Sewer Lien for Joseph Batalini - 1600 SW 17 Avenue

Matt Habibi said he represents the property owners of 1600 SW 17 Avenue. There are code violations regarding the sewer and the pool. The property was owned by Joseph Batalini, who resides there. In 2006 he had a first mortgage and started a business, for which he took out a loan. The loan resulted in a

second mortgage. The business failed, and Wachovia, under a Broward County case, began a foreclosure action. At that time he fell out of compliance and a lien was placed on the property assessing a daily \$100 fine beginning in January 2008. The business loan should not have been a lien on the property. He fought the foreclosure that took a number of years. When the foreclosure matter was resolved in September of this year, he immediately brought the property into compliance. The fine is now at \$244,000. The City's matrix brings it down to \$34,000. The pool issue is similar but was not reduced to a lien. It is about \$40,000. He understood it could possibly be reduced by about 25 percent. Batalini would pay the City's administrative or hard costs.

In response to the City Manager, Habibi confirmed that he represents Joseph Batalini and Trinity Homes, which now owns the property. When the lien was placed on the property it was Batalini's homestead. There is case law supporting that subsequent transfer of the property does not affect the homestead shield. Mayor Seiler felt that the responsibility falls on Trinity Homes because the prior owner is not responsible for the lien. He wanted to know if Trinity purchased the property at a discount because of the lien. Habibi did not know. The City Manager advised that staff believes the property is valued at about \$285,000 and Trinity purchased it for about \$100,000.

Mayor Seiler explained that for the Commission to make a decision, they need to know more about the underlying transaction and review the U.S. Department of Housing and Urban Development (HUD) statements. Often someone makes a low offer on a property then asks the City to eliminate the lien. The City Manager believed the property is now in compliance.

Mayor Seiler advised there is a lien reduction process that comes before the Commission on their afternoon agenda. The City Manager advised that the Commission's position is to not mitigate WaterWorks liens beyond the amount determined by the matrix.

Mayor Seiler noted there has already been a discount of \$185,000 and did not think there would be a lot the Commission could do, but he suggested Habibi submit the information in written form and follow the process.

The driveways have been built out but slabs have not been poured. Buildings will take up 40 percent of the site. The perimeter landscaping for future buildings will be completed once construction is complete.

All individuals wishing to speak on this matter were sworn in.

Members of the Commission announced with whom they had spoken and/or site visits made concerning this matter.

Mayor Seiler opened the floor for public comment.

Applicant Steven Chess, 773 Middle River Drive, said he wishes to install two dolphin poles on his property. He has moved them in 25 feet from each property line so as not to impact other properties. They are needed for hurricane protection. All documentation has been provided to the Marine Advisory Board. He was unable to attend the Board meeting. The application was denied. False allegations were made at the time about his character and intentions with the property. He is not operating a marine facility or renting out dock space. There is 685 feet between his property and the adjacent property. Across the canal are major vessels that have been permitted. The area was examined by the marine patrol and he was told there is no safety issue as it relates to the community using the waterway. The existing dolphin poles would be insufficient in the event of a bad storm.

Jim Concannon, president of Sunrise Intracoastal Homeowners Association, said that the Board of Directors voted unanimously to deny the request based on the Marine Advisory Board report of 2012 and their current report. There are a number of yachts in this area; it is a designated water-skiing area and there are commercial vessels across the way that altogether present a challenge to navigation safety. The Board does not see any hardship being presented in this request.

Donald Goldberg, 765 Middle River Drive, said he resides immediately to the east of Dr. Chess. The character of the Middle River has changed substantially recently. Safety is a concern. Chess' property is adjacent to the no-wake zone, where large boats come through and make turns that would present a

challenge for a boat extending 85 feet into the area. He and his wife have spoken to Chess' tenants, who have said they are renting slips and residing in a private rental unit inside his home. He believed Chess is misrepresenting renters as family members. Chess has attached wooden beams to the current dock out to the existing dolphin poles. He submitted a photograph of the beams that is attached to these minutes. He believed Chess' presentation is not accurate. In response to Mayor Seiler, Goldberg confirmed that Chess resides in the house.

In response to Commissioner Roberts, the City Manager explained that this application was heard in 2012 at which time the Marine Advisory Board voted to deny it. There is no clear process for an application with a denial recommendation. Chess requested the application be presented. It could return to the Marine Advisory Board if that is the desire of the Commission. Commissioner Roberts explained he brought the item forward because it has been ongoing for some time. He went on to detail some particulars relating to this being a water recreational area. He is concerned about safety relating to all of the activities that are occurring in the area and questioned at what point is there too much. Commissioner Roberts wanted to know the outcome of a notice to appear for Chess operating an illegal marina a couple of years ago. Assistant City Attorney Brad Weissman said it appears the matter was designated as "no information" by the City Prosecutor's Office in early 2011. Commissioner Roberts explained there were two people renting dock space and the area was referred to as a marina in the lease. Mayor Seiler said it appears the case was dropped in 2011. Chess said there is no restriction for docking a 126-foot boat at his home. He has corrected anything found to be a code violation. Goldberg is making false allegations and has had code violations. There was a safety inspection a long while ago and determined that there is no safety issue. There is a no-wake sign about 60 feet out which is where he would like to place his poles to secure his boat in the event of a hurricane. He is not running a marina. He has three homes and frequently changes locations. He shares his home with a caretaker. If the caretaker has a boat, he also watches his vessels. There is no lease arrangement for the dock. He uses the term "marina" in the lease for legal protection. The extensions are temporary and can be removed. There was no permit for them. An after-the-fact dolphin pole waiver was granted for his neighbor in a much more narrow part of the canal. The safety issue is a red herring. He has a pending legal case against the homeowners association for defamation of character. He is not a member of the homeowners association. He chose to reside in this area because it is not a gated community and not regulated by the homeowners association. Mayor Seiler pointed out that the Marine Advisory Board minutes reflect that area of the waterway is 580 feet. Chess indicated he was told by the engineer who prepared the survey that it is 640 feet. There is plenty of navigable waterway.

In response to Mayor Seiler, the City Attorney advised that the standard for the waiver is extraordinary circumstances. Chess said he has need of mooring in a storm which would not be possible without Commission authorization. He was not able to attend the 2012 Marine Advisory Board meeting. He was unable to indicate for Mayor Seiler the extraordinary circumstances under which the application was filed. Marine Facilities Manager Andrew Cuba advised that an individual purchased a nearby home and received an after-the-fact permit about two years ago. He did not recall the exact extraordinary circumstances. Mayor Seiler questioned why his application was denied by a unanimous vote of the Board. Commissioner Roberts was concerned that the Marine Advisory Board did not approve the application. This is the first one he can recall that has not been approved. He wanted more information to understand why Chess was able to secure approval for something more substantial in the past and as such why was this not granted.

There being no other individuals wishing to speak on this matter, a **motion** was made by Commissioner Roberts and seconded by Vice-Mayor Rogers to close the public hearing. Roll call showed: AYES: Commissioner Roberts, Commissioner McKinzie, Vice-Mayor Rogers and Mayor Seiler. NAYS: None.

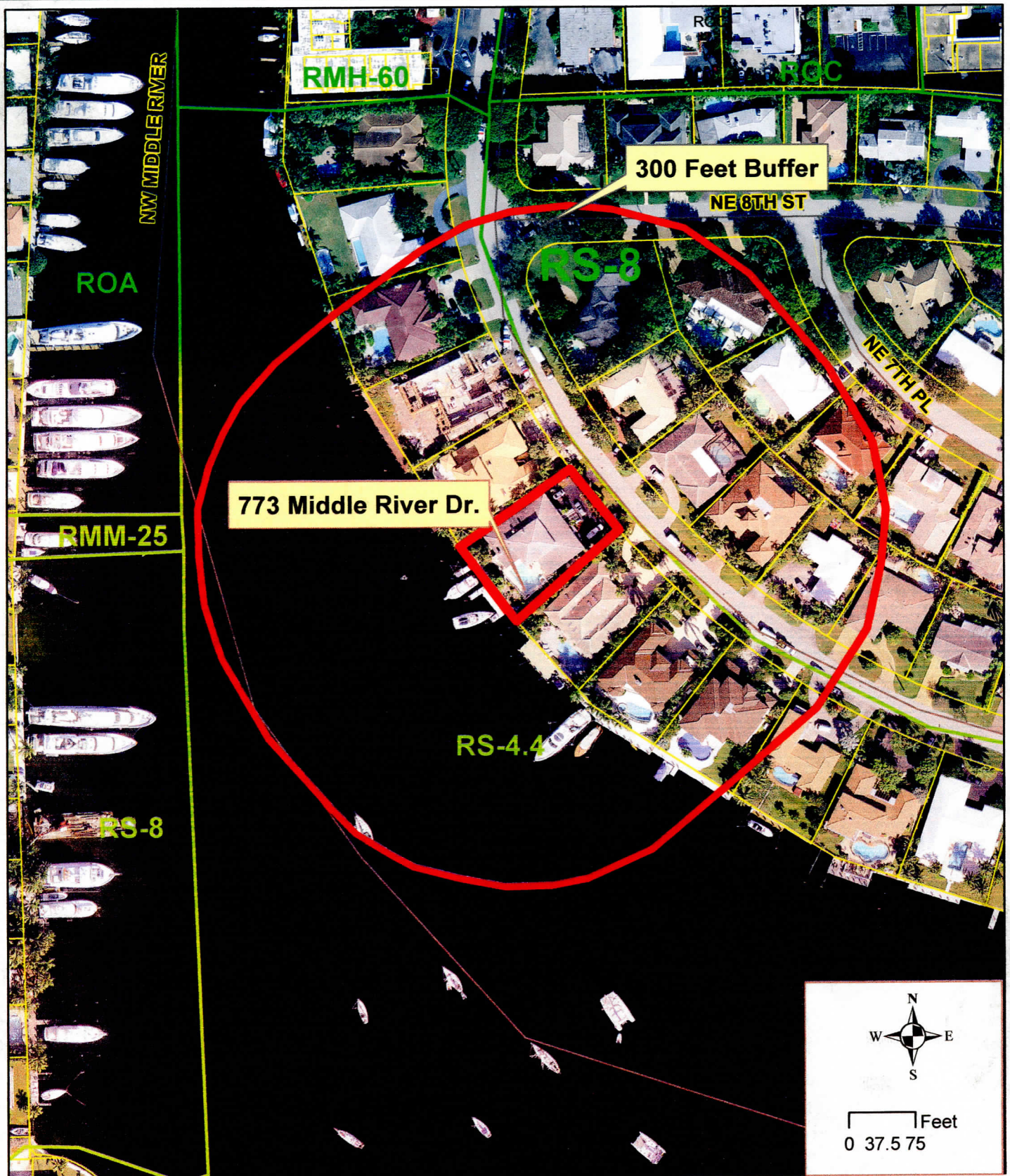
