It is recommended that the City Commission approve the attached lien settlement(s) as approved by the City Manager.

Pursuant to City Commission Resolution 13-235, approved on December 17, 2013, the City Manager presents his report of proposed lien settlements. Each applicant has complied with code violation(s) and the City's direct costs are included in the settlement recommendation. Each of these settlements is subject to the call-up provisions set forth in Resolution 13-235, and approved lien settlements must be paid no later than 45 days after the effective date of the reduction or the lien amounts revert back to the original amount.

**Resource Impact**

There is a positive fiscal impact to the City in the amount of \$38,652.25 in lien settlements.
