TITLE: Utility Work Agreement - I-95 Express High Occupancy/Toll Lanes -

Florida Department of Transportation (FDOT)

## <u>Recommendation</u>

It is recommended that the City Commission adopt a resolution ratifying the Utility Work Agreement (FDOT Participating in Expense) between the Florida Department of Transportation (FDOT) and the City for the 95 Express Phase 3A Project, FDOT Financial Project ID 433108-5-36-03 executed by the City Manager on January 5, 2015.

## **Background**

The Florida Department of Transportation is finalizing a Request for Proposal (RFP) for the 95 Express Phase 3A Project. This project is comprised of the design and construction of express corridor lanes from Stirling Road to north of Atlantic Boulevard, including associated road widening, bridge widening, and drainage work. This work is anticipated to impact underground infrastructure owned, operated, and maintained by the City, including water and wastewater mains.

FDOT has agreed to enter into an agreement to reimburse the City for consultant fees related to this project in an amount up to \$69,720. The two consultants selected for this project under continuing service agreements with the City are Hazen and Sawyer for water consultant services (Exhibit 1) and Keith and Schnars for wastewater consultant services (Exhibit 2) and their fees are estimated to be \$34,390 and \$34,810 for a combined total of \$69,200, which is below the maximum amount reimbursable from FDOT.

By entering into this Agreement, the City authorizes FDOT to reimburse the City for actual and related indirect costs accumulated in accordance with a work order accounting procedure prescribed by the applicable Federal or State regulatory body in accordance with the Utility Work Agreement signed by the City Manager (Exhibit 1).

## Resource Impact

There will be a positive fiscal impact to the City in the amount of up to \$69,720. Funding is contingent upon approval of the consolidated budget amendment CAM 15-0119.
