## SECOND EXTENSION TO FACILITY USE PERMIT

WHEREAS, pursuant to Motion, adopted at its meeting of March 17, 2015, the City Commission authorized a second extension of the Facility Use Permit; and

NOW THEREFORE, in consideration of the mutual promises and covenants set forth below, and other good and valuable considerations, the receipt and adequacy of which are hereby acknowledge, the parties agree as follows:

- 1. The foregoing recitals are true and correct and incorporated herein by reference.
- 2. Pursuant to Section 1 of the Facility Use Permit, the term of the Facility Use Permit is hereby extended for an additional one year term beginning April 3, 2015 and ending on April 2, 2016.
- 3. This Second Extension to the Facility Use Permit shall take effect upon execution by both parties.
- 4. All other terms and provisions of the original Facility Use Permit between the parties are hereby ratified, reaffirmed and shall remain in full force and effect.
