TITLE: Revocable License Agreement among the County, City and Andrews

Second Street, LLC and an Agreement Ancillary to Revocable License

Agreement for Improvements in the County Right of Way

Recommendation

It is recommended that the City Commission authorize the City Manager to execute (1) a Revocable License Agreement among the County, City and Andrews Second Street, LLC, ("Developer") for installation of landscaping, pavers, and irrigation improvements in the County right-of-way (ROW) (Exhibit 1) and (2) an Agreement Ancillary to Revocable License Agreement (Exhibit 2).

Background

The Department of Sustainable Development is requiring Andrews Second Street, LLC to expand the sidewalk and plant new trees between the sidewalk and travel lanes to comply with the intent of the Downtown Master Plan. These improvements lie within the County ROW on Andrews Avenue.

This practice was recently approved as part of the City's Complete Streets program. In order to implement Complete Street design features on a County roadway, the City is required to enter into a Revocable License Agreement with the County to ensure maintenance of the ROW improvements associated with the project.

The Revocable License Agreement calls for the City to act as the functional equivalent of a guarantor of the Developer's obligations under that instrument. In order to establish a means of recourse against the Developer, the City Attorney's Office recommends that the Agreement Ancillary to Revocable License Agreement be executed as a condition precedent to execution of the Revocable License Agreement. The Ancillary Agreement provides conditions, procedures and additional penalties for recourse against the Developer, that are otherwise not provided for in the underlying Revocable License Agreement between the County and City.

Resource Impact:

There is no fiscal impact to the City.
