Recommendation

It is recommended that the City Commission adopt a resolution appointing Law Offices of Steven A. Schaet LLC as special counsel to indigent defendants when appointed by the County Court in and for Broward County, Florida, in City of Fort Lauderdale municipal violation cases, and approving an agreement with Law Offices of Steven A. Schaet LLC.

Background

The City Attorney's Office prosecutes municipal ordinance violations in the County Court in and for Broward County Court pursuant to Section 4.12, Charter of the City of the City of Fort Lauderdale, Florida. Broward County Court judges appoint attorneys to represent indigent defendants in these municipal ordinance violation proceedings.

The City of Fort Lauderdale issued Invitation to Bid No. 453-11544, Criminal Defense Attorney Services ("ITB") to succeed an agreement that expires on April 10, 2015. An oversight in the ITB required a rebid *via* Invitation to Bid No. 453-11588. It is recommended that the City Commission adopt a resolution appointing the incumbent, Law Offices of Steven A. Schaet, LLC, as special counsel to represent indigent defendants charged with municipal ordinance violations when appointed by the County Court in and for Broward County, Florida, for \$195 per case during the period April 11, 2015, until the commencement of a contract arising out of Invitation to Bid No. 453-11588, and approving an agreement with Law Offices of Steven A. Schaet, LLC.

Resource Impact

There is a fiscal impact to the City in the amount up to \$30,000.00. Funding is available in the Legal Services account.
