### **EXHIBIT A – Business Description**

Bumble Bee Bike Tours is proposing a guided bicycle tour throughout downtown Fort Lauderdale and surrounding neighborhoods, showcasing its history, architecture, and points of interest. The 'model' for the tour strives to emulate similar bike tours that we have personally experienced in London, Barcelona, and Montreal.

The tour will include bikes, helmets, and culinary tastings from various establishments. The tour will take place on Public Rights of Way, and will only traverse private property in the case of entering food establishments. The bicycles are non-motorized, and the tour – at present – will be capped at 10 people, lasting approximately 3 hours.

We anticipate offering weekend tours, and if successful, offer mid-week tours as well. Below are images of (1) The bikes we will be using and (2) The anticipated route, which will deviate at times depending on traffic, events, new sights, etc.

At several points along the tour, the tour guide will discuss points of interest with tour participants – these stops will be in safe areas, out of the way of all other modes of traffic so as not to impede vehicular/pedestrian traffic flow. To that end, the route was carefully studied in order to accommodate the safety of tour participants. The tour guide shall be instructed – and equally instruct – tour participants on safety guidelines while cycling throughout the City.


