TITLE:	Ammunition – Florida Bullet Incorporated - \$34,527

Recommendation

It is recommended that the City Commission approve the proprietary purchase of ammunition from Florida Bullet Incorporated (Florida Bullet) in the amount of \$34,527.

Background

The Fort Lauderdale Police Department (FLPD) budgets funds annually to replenish its supply of ammunition. The ammunition is used for the following purposes:

- Monthly training programs are vital in maintaining the officers' firearms proficiency, and Florida Department of Law Enforcement firearms qualification requirements. This type of training requires specific ammunition for snipers, special weapons and tactics, and FLPD members assigned to non-specialized duties.
- 2) FLPD issues duty-carry rifle ammunition that is different than ammunition issued for training. Duty ammunition is chosen primarily for bullet performance and safety. This ammunition is required to be periodically exchanged to assure it is functional and free of contamination.
- FLPD continuously tests many types of ammunition. Testing of this specific ammunition has proven to have the best results for the applications in which it will be used.
- 4) Vista Outdoor is the manufacturer of the ammunition and Florida Bullet is the only authorized dealer in the State of Florida for CCI-Speer, Federal Cartridge and Force on Force products and is therefore proprietary.

Pursuant to Section 2-189(a), Code of Ordinances of the City of Fort Lauderdale, purchases of proprietary items may be made without the necessity of public bids. If the items exceed twenty-five thousand dollars, approval of the City Commission is required.

Resource Impact

There will be a fiscal impact to the City in the amount of \$34,527.
