TITLE: Software Licenses – Datalink Corporation - \$101,400

Recommendation

It is recommended that the City Commission award the purchase of Symantec NetBackup licenses to Datalink Corporation (Datalink) as an agent of Carahsoft Technology Corporation (Carahsoft), utilizing The Cooperative Purchasing Network (TCPN) agreement #R5011 with Carahsoft at a cost of \$101,400, approve the Datalink Terms and Conditions of sale agreement (Exhibit 1), and approve the Symantec Software License Agreement (Exhibit 2).

Background

The City must backup trillions of data bytes each night. The Information Technology Services Department utilizes Symantec NetBackup software and Exagrid disk-based backup hardware devices to manage data backups, data protection, and data and system recovery. Due to recent changes to software license compliance, the Symantec software currently in use is no longer compliant and requires the purchase of enterprise licenses in order to bring our systems up to current levels.

Symantec has partners who resell these licenses. Datalink is one of Symantec's National Platinum partners and the largest Symantec technical support partner program (TSPP) provider. The TSPP program provides better pricing, but is only available to select Symantec partners. This purchase includes one year of OneCall support services, which provides 24-hour real-time, solution-level support provided directly by Datalink and is being made utilizing the TCPN agreement. Prior to the award of this contract, TCPN was established to help governmental entities operate efficiently and economically, with the Region 4 Education Service Center established by the State of Texas under Chapter 8 of the Texas Education Code as their lead agency. The organization competitively bids and awards contracts to national vendors in accordance with purchasing procedures mandated by state procurement laws and regulations. TCPN is now a limited liability company organized under the laws of the State of Delaware.

4/7/15 15-0496 Pursuant to Section 2-181(7), Code of Ordinances of the City of Fort Lauderdale, the City may buy from another governmental entity contracts or bids whereby such contract or formal bid followed formal bid procedures of sealed written bids, public opening and legal advertising.

The City Attorney's Office cautions that the contract documents include a software license agreement (Exhibit 2) that, being a contract of adhesion that the provider refused to negotiate, contains provisions such as restrictions on use of the software and destruction of the software upon expiration or termination, which would be inconsistent with Florida law, and provides for the governing law to be that of California.

Resource Impact

There will be a fiscal impact to the City in the amount of \$101,400.
