TITLE:	Emergency Asphalt Restoration – Southern Florida Paving Group, LLC d/b/a Charlie Frymyer Paving - \$124,900 (two-year cost)

Recommendation

It is recommended that the City Commission award a two-year contract for emergency asphalt restoration to the lowest cost, responsive and responsible bidder, Southern Florida Paving Group, LLC d/b/a Charlie Frymyer Paving, (Southern Florida) utilizing the City's Contract (Form P-0001) in the estimated annual amount of \$62,450 (two year estimated amount of \$124,900) and authorize the City Manager to approve two, one-year renewal options, contingent upon appropriation of funds.

Background

The Public Works Department's Utilities Division is tasked with maintaining the water distribution system, wastewater, and stormwater collection systems. Most of the infrastructure is below ground level within the public right-of-way and may be located within State or County jurisdiction. Our community builders routinely have to disrupt the existing site conditions to make repairs to the infrastructure. Following the repairs, every effort is made to restore the work area to maintain compliance with State and County specifications. To complete the restoration process, asphalt is purchased as needed.

The Procurement Services Division issued Invitation to Bid number 453-11570 for emergency asphalt restoration and received two bids. Southern Florida is the lowest cost, responsive and responsible bidder in the estimated annual amount of \$62,450.

Resource Impact

There will be an estimated fiscal impact to the City in the amount of \$62,450. Future year expenditures are contingent upon approval of annual operating budgets.
