TITLE:	Notice of Intent to Transfer City-Owned Property to the South Florida Regional Transportation Authority for the Wave Streetcar Project

#### **RECOMMENDATION**

It is recommended that the City Commission adopt a resolution of intent to transfer property to the South Florida Regional Transportation Authority (SFRTA) for the Wave Streetcar Project's Vehicle Maintenance Facility (VMF).

### BACKGROUND

As part of the City's \$10.5 million capital contribution to the Wave Streetcar Project, land for the VMF needs to be transferred over to SFRTA, the project sponsor. Per the City/SFRTA agreement executed on December 5, 2014, parties committed to work cooperatively and in good faith to acquire 1801 SW 1st Avenue, a portion of which will be dedicated as the VMF, and is referred to as "Site K." To that end, the City has entered into a Real Estate Purchase and Exchange Agreement with All Aboard Florida – Operations LLC (AAF), with an effective date of April 1, 2015, to exchange City-owned property located at 101 N. Andrews Avenue (referred to as the "Heliport site") for the AAF-owned property located at 1801 SW 1st Avenue ("Site K", included as Exhibit 1).

This resolution serves as a notice of the City's intent to transfer title of a portion of Site K (see map as Exhibit 2) to the SFRTA following the closing of the land exchange with AAF, which will take place following the 60-day due diligence period within the purchase and exchange agreement, and the Federal Transit Administration's clearance of the site for compliance with the National Environmental Protection Act (NEPA). The closing date for the exchange of property will take place within 15-days following the NEPA approval date, which is expected to occur on approximately May 26, 2015. Transfer of title to SFRTA for the portion of the land associated with the VMF shall take place simultaneously.
