A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, DEDICATING A PUBLIC RIGHT-OF-WAY EASEMENT OVER CERTAIN REAL PROPERTY OWNED BY THE CITY OF FORT LAUDERDALE, SAID PUBLIC RIGHT-OF-WAY BEING MORE PARTICULARLY DESCRIBED BELOW; ACCEPTING SUCH DEDICATION TO BE HELD IN TRUST FOR THE PUBLIC; DIRECTING THE CITY CLERK TO RECORD A CERTIFIED COPY OF THIS RESOLUTION IN THE PUBLIC RECORDS OF BROWARD COUNTY, FLORIDA; REPEALING ANY AND ALL RESOLUTIONS IN CONFLICT HEREWITH; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Florida Department of Transportation (FDOT) is currently designing a "complete street" on NW 9th Avenue within the City of Fort Lauderdale from Sistrunk Boulevard to West Broward Boulevard as a Local Agency Program ("LAP") Project; and

WHEREAS, as part of the LAP Project, FDOT is redesigning a portion of the roadway and sidewalk on NW 9th Avenue within the City of Fort Lauderdale, which portion is on city-owned real property more particularly described below; and

WHEREAS, pursuant to FDOT requirements as part of the LAP Project, in order to reconstruct or improve roadway and sidewalks, a dedication of a public right-of-way easement is required; and

WHEREAS, dedication of this portion of city-owned real property for the purposes set forth above serves a valid municipal purpose;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That the City Commission of the City of Fort Lauderdale, hereby dedicates a public right-of-way easement in the below described real property to be used for public right-of-way purposes. The foregoing real property being dedicated is more fully described below:

<u>SECTION 2</u>. By adoption hereof the City Commission furthermore accepts such dedication of the public right-of-way easement to be held in trust for the public.
