TITLE:	Fleet Maintenance and Management Services – First Vehicle Services, Inc \$16,675,000 (three year estimated cost)

Recommendation

It is recommended that the City Commission award a three-year contract for the purchase of fleet maintenance and management services to First Vehicle Services, Inc., (FVS), in substantially the form attached, in the estimated amount of \$16,675,000 (three year estimated cost).

Background

The Public Works Department Sustainability Division Fleet Services Program generated a request for a solicitation intended to procure the services of an experienced contractor to provide fleet management and maintenance service for the City's fleet.

The background for the solicitation process included the following:

- October 2014 Request for Proposals (RFP) 555-11442 was issued for fleet maintenance and management services and central warehouse.
- December 2014 The RFP closed with a total of five firms submitting proposals in response to the RFP. Proposals were received from FVS, G4S Integrated Services, JTA Fleet Management Services (JTA), Shenandoah Fleet Maintenance and Management, and Vector Fleet Management.
- January 2015 The evaluation committee consisting of Carlos Berriz, Fleet Services Program Manager; Cris Dietz, Battalion Chief; Leigh Plotts, Administrative Assistant II; and Melissa Doyle, Solid Waste Coordinator met with AnnDebra Diaz, Procurement Specialist II, to evaluate the proposals and rank the firms according to the evaluation criteria. The evaluation committee shortlisted the top three ranked firms for the purpose of providing oral presentations. The shortlisted firms were FVS, G4S Integrated Services and JTA.

• February 2015 – The evaluation committee met to listen to the oral presentations. The evaluation committee rescored the proposals and ranked the firms according to the evaluation criteria.

Although JTA provided the lowest cost, they ranked last in all other criteria for the following reasons: JTA's proposal changed the specifications to exclude any repairs to vehicles that they recommend for replacement. These repairs would result in a financial liability to the City by becoming non-targeted items and exposing the City to additional expenses at their discretion (refer to page 25, Section 1, Item 7.4 of the vendor's proposal). Technician staffing levels were considerably lower than all other proposals and our current staffing levels. References provided experience with only sedans and motorcycles. Vendor did not provide any references for repair and maintenance of fire apparatus and heavy equipment. The financial review related to an automotive sales and service company that recently expanded into government fleet services.

• Based on the final ranking, FVS was the number one ranked firm as shown in the table below.
