## ORDINANCE NO. C-15-12

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF FORT LAUDERDALE, FLORIDA, TO ESTABLISH THE NUMBER OF MEMBERS THAT MAY BE APPOINTED TO SPECIFIED ADVISORY BOARDS OF THE CITY OF FORT LAUDERDALE; PROVIDING FOR SEVERABILITY; REPEAL OF CONFLICTING ORDINANCE PROVISIONS; AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

<u>SECTION 1</u>. That Section 8-31, Established, of Article II, Marine Advisory Board, of Chapter 8, Boats, Docks, Beaches and Waterways, of the Code of Ordinances of the City of Fort Lauderdale, Florida, is hereby amended to read as follows:

## ARTICLE II. MARINE ADVISORY BOARD\*

Sec. 8-31. Established.

There is hereby established a marine advisory board to serve in an advisory capacity to the city commission. <u>The Marine Advisory Board shall consist of a maximum of fifteen (15) members.</u>

<u>SECTION 2</u>. That Article II, Parks, Recreation and Beaches Board, of Chapter 19, Parks and Recreation, of the Code of Ordinances of the City of Fort Lauderdale, Florida, is hereby amended to create a new Section 19-34 to read as follows:

ARTICLE II. PARKS, RECREATION AND BEACHES BOARD\*

#### Sec. 19-34. Membership.

# <u>The Parks, Recreation and Beaches Board shall consist of a maximum of fifteen (15) members.</u>

<u>SECTION 3</u>. That the Marine Advisory Board and the Parks, Recreation and Beaches Board may continue to function with a membership in excess of 15 members until such time as the membership is reduced to the maximum membership provided herein by attrition through the expiration of terms of appointment, removal from office or resignation of duly appointed members.

<u>SECTION 4</u>. That members of the Marine Advisory Board and the Parks, Recreation and Beaches Board duly appointed prior to the adoption of this Ordinance shall remain in office until the expiration of their term of appointment, resignation or removal from office as provided in Section 2-217 of the Code of Ordinances or Resolution No. 97-187 adopted on November 4, 1997, as amended by Resolution No. 08-12 adopted on January 8, 2008 and cannot be reappointed if the number of members appointed to the respective board is 15 or greater. No person shall be appointed to Marine Advisory Board or the Parks, Recreation and Beaches Board if the number of board members appointed to the respective board is 15 or greater at the time of consideration for appointment or if the prospective appointee has exceeded the limitation on consecutive terms as provided in Section 2-217 of the Code of Ordinances.

<u>SECTION 5</u>. That the terms of appointment for members appointed to the Marine Advisory Board or the Parks, Recreation and Beaches Board, whose stated terms of appointment end dates have passed and continue to serve because a successor has not been appointed as provided by their appointing resolution, shall continue to serve an additional 30 days from the passage of this ordinance at which time their service on their respective board shall end.

<u>SECTION 6</u>. That if any clause, section or other part of this Ordinance shall be held invalid or unconstitutional by any court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby, but shall remain in full force and effect.
