TITLE: Annual Storm Drainage Contract Extension – GPE Engineering & General
Contractor Corp. - \$1,325,000

Recommendation

It is recommended that the City Commission approve a one-year contract extension for the Annual Storm Drainage Contract with GPE Engineering & General Contractor Corp. (GPE).

Background

On January 8, 2013 (CAM 12-2514) the City Commission approved a two-year unit price contract for annual stormwater construction services (Bid No. 623-11048, Project 11780) with GPE. This annual contract allows for three one-year extensions contingent upon mutual agreement and funding availability. The pricing in the existing contract is favorable to the City, therefore extending the contract at this time rather than rebidding a new contract is desirable.

**FIRST EXTENSION OF AGREEMENT

THIS IS A FIRST EXTENSION OF AGREEMENT, made and entered into this 17th day of February, 2015 by and between CITY OF FORT LAUDERDALE, a Florida municipality, ("CITY"), and G P E ENGINEERING & GENERAL CONTRACTOR CORP, a Florida Corporation ("CONTRACTOR").

WHEREAS, the CITY and G P E ENGINEERING & GENERAL CONTRACTOR CORP, a Florida corporation, entered into an agreement for an Annual Storm Drainage Contract – Project 11780, BID 623-11048, approved January 8, 2013 with Notice to Proceed dated March 5, 2013 (the Agreement); and

WHEREAS, the Agreement provides for three one-year extension options; and

WHEREAS, at its meeting of February 17th 2015, the City Commission of the City of Fort Lauderdale authorized this first one-year renewal of the Agreement,

NOW, THEREFORE, the CITY and the CONTRACTOR agree as follows:

1. The Agreement is renewed for an additional one year term beginning on March 5, 2015, and ending on March 4, 2016.


