TITLE:	Resolution waiving the Purchasing Code (Section 2-171 et. seq.) of the City of Fort Lauderdale and Authorizing the Purchase of Diversity Consulting Services from Bobcat Training and Consulting, Inc \$42,000

# **Recommendation**

It is recommended that the City Commission adopt a resolution waiving the Purchasing Code (Section 2-171 et. seq.) of the City of Fort Lauderdale, Florida, for the purchase of diversity consulting services for the Police Department, and authorizing the purchase of diversity consulting services in accordance with Cost Proposal "A" from Bobcat Training and Consulting, Inc.

### **Background**

It is important that the Fort Lauderdale Police Department maintain a positive relationship with City neighbors including the assurance that the department is operating in accordance with professional standards. In that regard, there is an immediate need to evaluate the Department's performance in community policing, community outreach, recruiting, hiring, training, and handling complaints relating to police conduct.

With the recent nationally publicized racially-charged internal investigation, Fort Lauderdale Police Department is requesting the assistance of Bobcat Training and Consulting, Inc. (Bobcat). Bobcat focuses on community policing and procedural justice principles outlined by the United States Department of Justice's Office of Community Oriented Policing. Their industry experts specialize in assisting law enforcement agencies to improve community partnerships and transparency through transforming law enforcement best practices. It is recommended that the City Commission authorize the purchase of services in accordance with Cost Proposal "A".

The need to evaluate the Police Department's performance in community policing, community outreach, recruiting, hiring process, training and handling complaints relating to police conduct is immediate. In order to meet the needs of this evaluation request and continue to comply with the purchasing code, it is recommended that the purchase of

consulting services be exempt from the requirements of obtaining competitive quotes and bids.

## Resource Impact

There will be a fiscal impact to the City in the amount of \$42,000.
