TITLE: Motion Authorizing Professional Services – Mills Pond Soccer and

Lacrosse Fields – Calvin, Giordano & Associates, Inc. – \$399,056

#### Recommendation

It is recommended that the City Commission award a contract for landscape architectural and engineering services for Mills Pond Park soccer and lacrosse fields to Calvin, Giordano & Associates, Inc., in substantially the form attached, in the amount of \$399,056.

## **Background**

On March 3, 2015 (CAM 15-0158), the City Commission approved the final ranking and commencement of contract negotiations for landscape architectural and engineering services of the Mills Pond Park soccer and lacrosse fields with the top ranked proposer, Calvin, Giordano & Associates, Inc. Staff has completed negotiations and is now requesting approval to award the contract.

The scope of services includes, but is not limited to, the design of three athletic fields, bidding services, and post-design construction services. Mills Pond Park is located at 2201 NW 9th Avenue. This project will include the installation of synthetic (artificial) turf or natural grass athletic fields including sports lighting, drainage and irrigation.

#### **Resource Impact**

There will be a fiscal impact to the City in the amount of \$399,056 for the engineering services and \$39,900.04 for estimated in-house project management fees, for a total of \$438,956.
