TITLE: Motion Authorizing Purchase of Tennis Court at Hortt Park – Solo

Construction & Engineering Co. - \$59,500

Recommendation

It is recommended that the City Commission approve a contract for the award of the Hortt Park Tennis Court Project, in substantially the form attached, to Solo Construction & Engineering Co. (Solo), in the amount of \$59,500.

Background

The Hortt Park Tennis Court Project includes the construction of one new tennis court and all related activities as per plans and specifications. The work includes tree relocating and palm removal; existing irrigation adjustments; new sodding; soil excavating and removal; rock base compacting; construction of a 60-foot by 120-foot asphalt tennis court; netting, anchoring, surfacing and striping per United States Tennis Association specifications; building of a 10-foot high chain link fence; and all other related work per plans and specifications.

Invitation to Bid 253-11540 was opened on March 2, 2015 and three responses were received. Solo submitted the lowest responsive and responsible bid. Staff is therefore requesting approval to award the Hortt Park Tennis Court Project to Solo.

Resource Impact

There will be a fiscal impact to the City in the amount of \$59,500 for the contract award. The available balance in the chart below reflects the amount remaining after the removal of pre-encumbrances established for this purchase. Pre-encumbrances are in the total amount of \$34,500.
