## Recommendation

It is recommended that the City Commission adopt a Resolution appointing the law firm of Hough Law Group, P.A., as special counsel representing the City of Fort Lauderdale in connection with the Chapter 11 bankruptcy filing regarding Sixth Street Plaza; Inc., and the Chapter 11 bankruptcy filing regarding Maria J. Freeman, and any anticipated adversarial proceedings in connection therewith.

## **Background**

The City of Fort Lauderdale has a vested interest in this matter evidenced by a third mortgage given by Sixth Street Plaza, Inc. in favor of the Fort Lauderdale Community Redevelopment Agency (CRA), which mortgage was modified to \$697,990.50 and recorded in August 2010. In addition, the City filed code liens, which attach to both the Tuskegee and Progresso properties owned by Sixth Street Plaza, Inc. The City Attorney's Office recommends appointing Hough Law Group, P.A., as special counsel and to establish the fees for special counsel.

Special counsel proposes an hourly rate of \$325.00 per hour for partners, \$225.00 per hour for associates and \$125.00 per hour for paralegals to represent the City's interests including attending all bankruptcy court proceedings and conducting discovery. A copy of the Hough Law Group, P.A. firm resume is attached.

# Resource Impact

There is a fiscal impact to the City in the amount of Fifteen Thousand Dollars (\$15,000.00). Funding is available in the Legal Services account.
