# **Statement of Proposed Services**

(a) Assessment of capability and approach to perform the scope of service:

Parkway Strategies is a boutique Tallahassee-based firm that specializes in providing lobbying services in the areas of water, protection and management of natural and marine resources, tourism, real estate and finance. The firm was formed in January, 2014 by primary lobbyist Derron Bennett to combine the expertise and experience of a seasoned policy advocate with the fresh ideas and technological wizardry of young professional. The firm's two principals include Mr. Bennett and Sue Mullins, who is a 20-year veteran of environmental, real estate, industry, utility and local government advocacy.

We have many years of collective experience working with the federal, state, local and regional governments that are essential to assisting the City of Fort Lauderdale with the City's priorities before the United States Congress and Executive branch agencies. Our team is well-known and well-respected in the Capitol, and our legislative, agency and appropriations experience will no doubt benefit the diverse needs of the City.

Parkway Strategies possesses a strong working knowledge of all legislative, administrative and regulatory processes as they relate to a variety of local government issues and appropriations, as well as a clear understanding of the large urban and economic drivers of the City of Fort Lauderdale. Mr. Bennett has very close ties to lawmakers from both parties in South Florida, and worked in the Florida Senate as an analyst on issues specific to Local and General Government Appropriations.

Ms. Mullins drafted bills and lobbied Majority and Minority party legislators for sponsorship, passage and funding major state programs, and has close ties to Florida's congressional delegation and rural lawmakers from other states. She has also worked for the Senate Democratic Office as lead analyst for the environment, General

Government Appropriations, and Indian River Lagoon and Lake Okeechobee Basin issues. Her prior work as Government Relations Manager at The Nature Conservancy allowed Ms. Mullins to work in numerous local governments, including City of Fort Lauderdale, as a consultant to help create ordinances and campaigns to win voter approval for dedicated land conservation funding, invasive plant eradication and downtown redevelopment programs. Ms. Mullins' conservation work alone in Florida's cities and counties have created \$1.2 billion in local funds for environmental and agricultural land and water conservation.

While the firm is a new entity for the purposes of the umbrella organization known as Parkway Strategies, the team has worked together for years and has a winning record on issues, campaigns and legislation by bringing together not just a commitment to local government issues, but a strong work ethic and solid relationships with lawmakers and staff throughout Congress, state and federal agencies and local governments.

## (b) Staff qualifications:

Parkway Strategies has a profound familiarity with and understanding of issues important to local government entities, especially those relating to appropriations, local project requests, City budgets and revenue sources. Having both worked on behalf of all of South Florida's water projects, the Indian River Lagoon, Everglades and Lake Okeechobee restoration efforts in our capacity as Senate Analysts and environmental/agricultural lobbyists, we have worked from the appropriators' standpoint and understand the tradeoffs and balancing that takes place.

We each possess a Master's level education in fields relevant to natural resources and public policy, and have lobbying experience spanning 20 years. One of the firm's principals, Sue Mullins, drafted the legislation governing the state's Florida Forever program, created the Rural and Family Lands Protection Program, and worked closely with Florida's congressional delegation on the 2012 RESTORE Act. Ms. Mullins also

worked on contract with 14 Florida counties, including City of Fort Lauderdale, to achieve local dedicated funding for land conservation between 1998 and 2008.

Parkway Strategies has worked closely with appropriation committee and sub-committee staff and chairpersons, and advocated for local water projects and related appropriations items. As staff and as lobbyists we regularly prepare budget analyses and proviso language to specify funding for local government projects from water supply, stormwater and wastewater management and waterway restoration to recycling, transportation, economic development and climate change resiliency projects. We have an insiders' knowledge and access to staff and Members working on the budget for South Florida's counties. Our decades-long relationships with State Legislative and Congressional Members and staffs have positioned us as a thorough, trusted and sought-out team for many issues facing Florida's local governments.

Our firm's experience in federal lobbying includes a working knowledge of legislative affairs, policy frameworks, congressional staff and publications, timelines and interpretations of legal, practical and financial implications of legislation, policy and budget statements. We have worked primarily on federal policy and appropriations in relation to the U.S. departments of Interior, Agriculture and Transportation, and the Environmental Protection Agency. We have registered success in areas relating to the Clean Water Act, the Natural Resources Conservation Service, Farm Bill programs including the Farm and Ranch Lands Protection Program and Grassland Reserve Program, the RESTORE Act and its Gulf Coast Ecosystem Restoration Task Force, as well as obtaining loans from Clean Water State Revolving Fund.

#### (c) Estimated timetables:

The first four weeks that Congress is scheduled to be in Session in January 2015 will provide the City of Fort Lauderdale lobby team with the opportunity to re-familiarize incumbent Members with the City's priorities and interests for the 113th Congress. This initial period of adjustment to a Republican Majority in both Chambers will also allow us

the time to acquaint new Florida Representatives with the issues and funding challenges faced by the City.

The following six months before the August recess will provide the team with ample opportunity to educate Members and promote the City of Fort Lauderdale's priority bills and budget items to the Florida delegation, and to key members and staff in leadership and committees of substance.

Based on the scheduling of Standing Committee's meetings, as published in the *Congressional Record*, we will advocate with committee members and staff on presentations, issues and bills of interest to the City. As our legislation of interest makes it through to a markup meeting of the committee and our measures are scheduled for consideration, our team will lobby to ensure the bills pending before committees will be recommended to the full House or Senate, and be amended in any substantive way the City recommends.

# Scope of Work

Parkway Strategies will work closely with officials and staff of the City of Fort Lauderdale in the development and ongoing implementation of programs of importance, and thereby propose the following strategies:

Assist the City in preparing its annual federal legislative agenda, including any needed substantive changes to law, and requests for grants and appropriations. We will provide information to City officials and staff about the priorities of the President and Congress in order to help specify and enhance the City's goals and priorities.

Regularly monitor, analyze and report on all proposals, legislation, amendments, committee hearings, intelligence and budget items of interest to the City Manager and

identified staff, reviewing each legislative item for potential amendment to better reflect the City's interests and priorities.

Draft legislative proposals in the form of substantive bills, amendments, budget proviso language, and find sponsors for the language as bills move through Congress.

Directly lobby Members and staff, and testify before committees as necessitated by our bills, amendments and budget items. Our advocacy includes initial outreach and education via in-person and written communications, followed by substantive meetings and filling follow-up requests for information, and finally issuing thank-you letters and expressions of support and appreciation.

Work respectfully to defeat any legislative proposals or budget items that would have negative consequences for the City and its priorities.

Represent the City of Fort Lauderdale at committee hearings, agency meetings and rule development hearings, and provide opportunities for City staff experts and officials to attend and testify at same.

Help identify budget and grant funding options pertaining to City needs and priorities, and work to move identified options through the budget process, advocating with individual Members, before committees and once the budget comes before both Chambers and the President. Additionally, we will craft proviso language to aid the City in implementing the budget to best benefit City needs.

Facilitate and schedule any meetings desired by the City with Members, staff, federal agency officials and Executive staff.

Assist staff in submitting grant requests, revising grant proposals and advocate before regional governing boards to highly prioritize and rank our proposals. Upon request, we will also write grants on behalf of the City and work to maximize the City's grant awards.

Work to identify and advance federal programs and projects that can help develop the

City's "Press Play Fort Lauderdale Strategic Plan 2018" goals and activities.

Provide intelligence on policy, agency or political developments that could help refine

the City's priorities or strategies on legislative proposals, grant requests, budget items

or agency implementation and rulemaking.

Work closely with Florida delegation members to promote the City's priorities, and

coalesce with other advocates, neighboring cities and others on common issues and

funding items where appropriate and advantageous.

Provide written weekly updates and progress reports on bills and budget items, and

make ourselves available for phone and conference calls as necessary to inform and

liaise with the City and revise approaches or priorities as needed.

Regularly meet with City management and appear before the City Commission, as

requested, to best learn and represent the city before federal entities.

Provide an annual report of legislative outcomes, including the final status of the City's

priorities and a summary of the impact that major legislative changes and appropriations

may have on the City of Fort Lauderdale.

#### Tab 9 City of Fort Lauderdale's Needs and Proposed Plan

Because the City of Fort Lauderdale is a waterfront community and the seventh largest municipality in the State of Florida, its needs for adequate housing, transit, natural resource protection and community safety are paramount. Our team will work to deploy every potential policy and funding mechanism to bear on what we see as the following key issues for the City:

Homelessness
Urban Area Security and Public Safety
Transportation
Climate Change and Resiliency

The tourism and second-home economies contrast starkly with the low-income residences located within the northwest quadrant of the City, making for extremes in citizens' standards of living. More than 70 percent of residents in the city's NW have income levels at eighty percent or below AMI, and has necessitated establishment of a Neighborhood Revitalization Strategy Area (NRSA) in the community. Both federal and State funds are targeted to the NRSA and other sections of the northwest quadrant of the community to support economic development, infrastructure and housing initiatives, from Sunrise Boulevard to Broward Boulevard and I-95 to NW 7th Avenue. The boundary covers Lincoln Park, Sistrunk, Dorsey-Riverbend and Dorsey Heights Areas.

Clearly, advocating for even greater federal funds including Emergency Solutions Grant Program (ESG); HOME Investment Partnership Program (HOME); Community Development Block Grant Program (CDBG); and Housing Opportunities for Persons with HIVIAIDS Program (HOPWA) will be a major priority for federal lobbying by Parkway Strategies.

In addition, we intend to support the city's Livable Downtown initiative to bring federal policy and funding programs to bear on the City's urban center by helping add to the


variety of public spaces and transportation options as well as a mix of housing, shopping, employment and entertainment opportunities. With regard to transit options, the City's Transit Oriented Development guidelines to expand transit station areas in the Downtown Regional Activity Center can be enhanced by further federal transportation funds. Our plan will be to focus dollars on All Aboard Florida intercity passenger rail, the Wave Streetcar, Broward Central Terminal and expanding the Tri-Rail Coastal Link passenger rail on the Florida East Coast line.

Our primary purpose in this advocacy is to enhance public safety and urban core vitality. We will help guide and encourage future development within proximity to premium transit stations, working in coordination with the City's Downtown Master Plan. In this, our team will lobby for funds and policy frameworks aimed at creating safe, pedestrian-friendly, energetic station areas that support the continued growth of the downtown as a live, work, and play, so that economic activities enhance and bring together, rather than separate the diversity of City residents and visitors. By seeking USDOT revenue sources for greenways, complete street initiatives and pedestrian safety, we will pursue funds for several mobility options, emphasizing multimodal transportation to keep people moving in the City, retain its quality of life, protect the environment, and continue the economic health and vitality of the Downtown.

With regard to advocating for the City's adaptability and resiliency to climate change, we will lobby for federal funds to acquire and restore land, including barrier islands and coastal plains, as well as funds for flood prevention and hazard mitigation. Accessing Clean Water State Revolving Fund grant programs though our high-level contacts with congressional and agency staffs, we will lobby for further water, sewer, and stormwater infrastructure improvements as well as Riverwalk enhancement. We will pursue any short-range and comprehensive strategies to address climate change and sea level rise mitigation with Congress, including directing any federal funds toward Fort Lauderdale Beach re-nourishment, revitalization, and enhancement projects.

Derron Bennett and Sue Mullins will act as the legislative and executive lobbyists. Sue Mullins will also act as the policy director and point of contact. In addition, during Congressional hearings and In-Sessions, we employ administrative assistants and "runners" to further ensure that the legislative priorities of the City of Fort Lauderdale are fully addressed.
