

**SECOND RENEWAL AND AMENDMENT TO AGREEMENT  
BETWEEN THE CITY OF FORT LAUDERDALE  
AND STRAIGHTLINE ENGINEERING GROUP, LLC**

THIS IS A SECOND RENEWAL AND AMENDMENT TO AGREEMENT made and entered into this \_\_\_\_ day of \_\_\_\_\_, 20\_\_, by and between CITY OF FORT LAUDERDALE, a Florida municipality, ("CITY"), and Straightline Engineering Group, LLC, a Florida limited liability company (Contractor).

WHEREAS, the CITY and the CONTRACTOR entered into an Agreement for Annual Concrete and Paver Bricks Services, ITB 233-11030 Project 11762, dated August 21, 2012, for a two-year term with three one-year extensions, and Amendment 1 to Contract dated April 2, 2013, and First Renewal of Agreement from August 21, 2014 to August 20, 2015, (collectively, "Agreement"); and

WHEREAS, the Agreement provides for three one-year renewal options; and

WHEREAS, at its meeting of June 16, 2015, the City Commission of the City of Fort Lauderdale authorized the second one-year extension of the Agreement as well as an increase of the total annual contract amount to \$336,946.

NOW, THEREFORE, the CITY and the CONTRACTOR agree as follows:

1. The Agreement is renewed for one year beginning on August 21, 2015, and ending on August 20, 2016
2. The total awarded contract amount shall be increased to \$336,946
