Park

Recommendation

It is recommended that the City Commission approve an application for a temporary beach license and outdoor event agreement and authorize the City Manager to execute the agreement and supplemental addendum with the Florida International University Board of Trustees (FIU) on behalf of the City of Fort Lauderdale.

Background

City staff has been working closely with the event organizer regarding event topics such as logistics, maintenance and security as detailed below. Amplified music was discussed and the event organizer was advised of the noise ordinance and possible concerns.

The event organizer will pay for all event costs and submit the required certificates of insurance. They will also secure all other necessary permits and license that are required from other agencies. Civic and merchant associations have been notified as appropriate regarding this event. Event details are included in the event application as attached. The applicant is a non-for profit organization, therefore the City Manager is recommending no charge for the beach license.

Authorization for the execution of the event agreement is contingent upon the City Attorney's Office receiving and approving a validly executed agreement.
