**TITLE**: Motion to Approve a Proprietary Purchase for the NW 2<sup>nd</sup> Avenue Water

Tower Art Project – Art Light Space, LLC - \$201,800

### Recommendation

It is recommended that the City Commission approve the proprietary purchase of artistic and computer design services and design and construction inspection services from Art Light Space, LLC in the amount of \$201,800.

## **Background**

On December 17, 2014 the City Commission approved the artistic paint and lighting concept (CAM 14-1593) for the NW 2<sup>nd</sup> Avenue elevated water storage tank. In an effort to coordinate the art and construction related work, staff requested proposals from Hazen and Sawyer, P.C. and Art Light Space, LLC. The work identified in the proposal from Art Light Space, LLC includes the creation of drawings and specifications necessary to bid and construct the artistic painting and lighting features.

Pursuant to Section 2-189(c)(1), Code of Ordinances of the City of Fort Lauderdale, the City may purchase proprietary items, such as works of art for public places, without the necessity of public bids.

#### **Resource Impact**

There will be a fiscal impact to the City in the amount of \$201,800.
