**TITLE**: Motion Authorizing an Amendment to the Lease with 105 NE 3<sup>rd</sup> Street,

LLC for the City's Health & Wellness Center – \$3,600

#### Recommendation

It is recommended that the City Commission approve an amendment to the lease agreement for the City's Health & Wellness Center at 105 NE 3rd Street authorizing \$3,600 a year (\$300 monthly) in landscaping fees to the owner (105 NE 3rd Street, LLC).

### **Background**

On March 19, 2013, the City Commission approved a six (6) year lease with two optional five (5) year extensions for the rental of office space at 105 NE 3rd Street for the City's Health & Wellness Center (CAM #13-0472). As of July 1, 2015, the City has started the third year of the lease that commenced on July 1, 2013 and will expire on July 1, 2019. Currently, the City is paying \$4,065.90 in monthly lease payments.

The City's current lease requires that the City maintain the landscaping around the property at 105 NE 3rd Street. However, this requirement has created some administrative issues for the City, in addition to some liability concerns related to City staff performing work on private property. The property owner, 105 NE 3rd Street, LLC, has agreed to amend the lease to transfer the landscaping maintenance from the City at the cost of \$300 a month (\$3,600 yearly) in landscaping fees. This will increase the City's monthly lease payment from \$4,065.90 to \$4,365.90.

## **Resource Impact**

There is a fiscal impact for Fiscal Year 2015 in the amount of \$300. There will be a fiscal impact for Fiscal Year 2016 in the amount of \$3,600. Future expenditures are contingent upon approval and appropriation of the Fiscal Year 2016 Budget.
