- TITLE:Motion to Approve Change Order Purchase for Software Support Services
for Utility Billing N. Harris Computer Corporation \$33,300

Recommendation

It is recommended that the City Commission approve a change order purchase for proprietary software support services from N. Harris Computer Corporation in the amount of \$33,300.

Background

On April 15, 2014, the City contracted with Cayenta, a division of N. Harris Computer Corporation, to create an interface between the Cayenta Utility Billing Software and the newly implemented QAlert/LauderServ Software. The goal is to seamlessly integrate service requests between the two systems.

The interface process allows for the service requests created in the Cayenta Utility Billing Software to be automatically assigned to the field crews' mobile devices. The crews will efficiently complete the service requests in the field; subsequently, the interface process will update these requests in the Cayenta Billing System.

The City initially paid \$24,050 for the development of this interface which was under the threshold for Commission approval. However, since that time, Qalert/LauderServ has significantly expanded in scope and is now used to handle neighbor, as well as, internal requests between departments. This expansion in scope for Qalert/LauderServ requires a change in scope for the interface resulting in a change order in the amount of \$9,250 for the additional support, increasing the total cost of the project to \$33,300. Therefore, if the cost of a proprietary purchase is greater than \$25,000, then the approval of the City Commission is required.

Pursuant to Section 2-189, Code of Ordinances of the City of Fort Lauderdale, Florida, the City may purchase proprietary items, as defined in Section 2-173, without the necessity of public bids. As defined by the Code, a proprietary item is not readily available from more than one supplier, manufacturer, or person and is unique in nature. The interface process is created by Cayenta and is proprietary to N. Harris Corporation.

Resource Impact

There will be a fiscal impact to the City in the amount of \$33,300.00.
