A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AUTHORIZING THE MAYOR TO REQUEST THE FLORIDA DEPARTMENT OF TRANSPORTATION ("FDOT") TO CONVEY SURPLUS PROPERTY TO THE CITY OF FORT LAUDERDALE ("CITY") TO BE UTILIZED FOR THE PUBLIC PURPOSE OF PROVIDING CONTINUED USE AS PART OF HISTORIC WOODLAWN CEMETERY, SUCH PROPERTY BEING IDENTIFIED IN THE LEGAL DESCRIPTION AND SKETCH ATTACHED AS EXHIBIT "A"; PROVIDING AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, FDOT acquires real property for transportation facilities for the citizens of the State of Florida; and

WHEREAS, FDOT is permitted by law to convey real property that FDOT no

longer needs for transportation and is authorized to convey such surplus property to other

public entities to further the public needs of the State of Florida; and

WHEREAS, the City is requesting that FDOT convey to the City the surplus

property described on Exhibit "A"; and

WHEREAS, the City can utilize FDOT's surplus property described on Exhibit "A"

to add to the historic Woodlawn Cemetery; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, THAT:

<u>SECTION 1:</u> The foregoing recitals are true, correct and incorporated into this Resolution by this reference.

<u>SECTION 2:</u> The City requests FDOT to convey title to the surplus property described on Exhibit "A" to the City pursuant to Section 337.25(4)(d), Florida Statutes, provided FDOT can provide clear and marketable title to the property and subject to approval of the City Attorney.

<u>SECTION 3:</u> The surplus property to be conveyed to the City by FDOT will be used for the public purpose of assisting the City in completing a more comprehensive restoration of historic Woodlawn Cemetery which will be in the best interests of the general public of the City.

<u>SECTION 4:</u> Upon adoption of this Resolution, the City Clerk shall forward an executed copy of this Resolution to Amanda Shore, Florida Department of Transportation, 3400 W. Commercial Blvd., Ft. Lauderdale, Florida 33309-3421, for further handling.

<u>SECTION 5:</u> This Resolution shall take effect immediately upon passage.




