TITLE: Motion Authorizing Design Services for Fort Lauderdale Executive Airport

Runway Pavement Rehabilitation – HDR Engineering, Inc. – \$51,740 Task

Order

#### Recommendation

It is recommended that the City Commission approve a task order (Exhibit 1) for design services for the Fort Lauderdale Executive Airport (FXE) Runway Pavement Rehabilitation with HDR Engineering, Inc. (HDR), in an amount not to exceed \$51,740.

## Background

The Florida Department of Transportation (FDOT) initiated a Statewide Airfield Pavement Management Program in order to support maintenance and rehabilitation activities for airports within Florida. In May 2013, the FDOT conducted an inspection of the runway and taxiway pavements at the FXE. The report recommends that a combination of seal coat, crack/joint sealing, and/or overlay be applied to both runways to extend the pavement life and reduce the rate of pavement deterioration. Based on the results of the report, the FXE entered into a grant with the FDOT in the amount of \$432,000 to provide funding for 80% of the design and construction costs for rehabilitating the airfield pavement along both runways.

This task order is being entered in pursuant to the FXE General Engineering Aviation Consulting Services Agreement with HDR, approved by the City Commission on August 19, 2014 (CAM # 14-0924). The scope of services for this task order includes, but is not limited to, evaluating the existing airfield pavement, performing geotechnical testing, conducting airport staff review meetings, preparing construction plans and bid specifications, and assisting during the bidding process.

Funds for this task order are available from within the project budget and from a Joint Participation Agreement from the FDOT for the reimbursement of approximately 80% of the design costs (\$41,392).

The item was reviewed and unanimously approved, 6 to 0, at the Airport's Aviation 10/06/2015

Advisory Board (AAB) Meeting on August 27, 2015 (Exhibit 2).

### **Resource Impact**

There will be a fiscal impact to the City in the amount of \$51,740 for the task order and \$36,208 for estimated in-house project management fees for a total of \$87,948.
