TITLE: Resolution Imposing Special Assessment Liens for Lot Clearing

Recommendation

It is recommended that the City Commission adopt a resolution authorizing the imposition of special assessment liens for costs associated with cleaning and removal of debris associated with properties listed in Exhibit 1.

Background

Pursuant to Section 18-14, Code of Ordinances of the City of Fort Lauderdale (Code), the City cleaned and removed debris from properties listed in Exhibit 1. Included within the exhibit are the actual costs and expenses associated with abating the nuisance. Those costs and expenses for lot cleaning is recorded against a respective property as a special assessment lien in the public records of Broward County, pursuant to Section 18-15 of the Code.

In accordance with the Section 18-13 of the Code, a property owner is notified to clean and clear a property within ten days of the date of a citation. When compliance is not achieved within the required timeframe, the property is cleared and cleaned by the City's contractor. A statement of costs and expenses is mailed to the property owner for requesting reimbursement.

If the City does not receive payment on the outstanding balance within 30 days from the date of the mailing, the case will be referred to the City's collection agency. Additionally, interest will accrue on the outstanding balance at a rate of 4.75% annually. This rate does not exceed the authorized maximum interest of 8% per year described in Section 170.09, Florida Statues.

Resource Impact

Should the City receive payment on the outstanding balance, there will be a positive fiscal impact to the City in the amount of \$10,530.13.

Funds received will be deposited into the general fund, as detailed below.
