TITLE:	Motion to Approve Loader Backhoe and Yard Wheel Loader – Nortrax, Inc \$232,495

Recommendation

It is recommended that the City Commission approve the purchase of a loader backhoe and yard wheel loader via Florida Sheriffs Association Contract 15-13-0904 from Nortrax, Inc. in the amount of \$232,495.

Background

Public Works uses backhoes and loaders to excavate for underground repairs and replacement of critical infrastructure which have exceeded their life expectancy resulting in frequent breakdowns and costly repairs.

Properly functioning construction equipment such as backhoes and loaders are essential to operations of the Public Works Utilities Division and to ensuring the resiliency of City infrastructure. Backhoes and loaders are used daily for excavating, back filling, trenching, loading and unloading of material. They are also essential assets throughout the preparation and response procedures for natural emergencies such as hurricanes, king tides, and tornadoes. Additionally, this equipment plays a critical role during post disaster recovery, debris collections, and roadway openings.

When backhoes and loaders are not available, production slows down considerably because staff has to use jackhammers, pipe saws, sledgehammers, picks and breaking bars to break through asphalt, road rock and concrete to repair, install or maintain our infrastructure

Pursuant to Section 2-181(8), Code of Ordinances of the City of Fort Lauderdale, Florida, this purchase will be made from Nortrax, Inc. *via* Florida Sheriffs Association Contract 15-13-0904, which was entered into following a fair and competitive process that included public notice, sealed written or secure electronic bids, and public bid opening. The cost of the loader backhoe is \$93,334. The cost of the yard wheel loader is \$139,161.

Resource Impact

There will be a fiscal impact to the City in the amount of \$232,495.
