Task Order

Recommendation

It is recommended that the City Commission approve Task Order No. 2 to EDSA, Inc. (EDSA) in an amount not-to-exceed \$2,844,519 to complete the design development, construction documents, and provide construction administration for the Las Olas Boulevard Corridor Improvement Project (P11900).

Background

On February 4, 2014 the City Commission approved a Consultant's Agreement with EDSA (CAM #14-0161) for the design and implementation of the Las Olas Boulevard construction improvements in a not-to-exceed amount of \$4,500,000, including all reimbursable expenses. On February 4, 2014, the City Commission also approved Task Order No. 1 to EDSA in a not-to-exceed amount of \$2,011,900, including reimbursable expenses. The scope of Task Order No. 1 was to take the project from concept to schematic design (30% design) and submit to the City's Design Review Committee (DRC) for site plan approval.

The City Commission approved the schematic design on October 12, 2015 at a Joint City Commission and Beach Redevelopment Advisory Board (BRAB) Public Workshop. EDSA will submit the documents for DRC/site plan approval on November 3, 2015. The estimated expenditure for Task Order No. 1 is approximately \$1,400,000.

Staff is now requesting authorization to execute Task Order No.2, which will develop the 30% schematic design to 100% complete design, including the construction documents and construction administration.

The not-to-exceed cost for this task is \$2,844,519, including reimbursable expenses. This cost is included in the \$4,500,000 originally authorized in the Consultant's Agreement. It is estimated that the design phase will be completed in nine months.

There will be a fiscal impact to the City in the amount of \$2,844,519 for the task order and \$100,000 for in-house project management fees, for a total of \$2,944,519.
