Republic Services of Florida, Limited Partnership - \$897,612

Recommendation

It is recommended that the City Commission approve continuation of trash and recycling collection services, public spaces and special events for a period of up to six months commencing November 1, 2015 with Republic Services of Florida, Limited Partnership, in the amount of \$149,602 per month, not to exceed a total amount of \$897,612, contingent upon finalization of an agreement and City Attorney review.

Background

On June 17, 2014 (CAM 14-0641), the City Commission awarded Contract 542-11342 to Republic Services of Florida, Limited Partnership for a period of one year with three, one-year renewal options. The contract was effective August 1, 2014 through July 31, 2015. This contract provides solid waste and recycling collections for approximately 1,200 trash and recycling receptacles placed in public spaces throughout the City of Fort Lauderdale, including bus stops, sidewalks, Las Olas business corridor and along our beaches.

On June 16, 2015, City staff provided Republic Services of Florida, Limited Partnership written notice of a 90-day administrative extension, securing services as provided under their contract through October 31, 2015. This additional time was intended to allow for rebidding of these services. Solicitation 853-11629 was issued on July 13, 2015 and closed on August 17, 2015. Bids received in response to the solicitation have not been rejected.

Staff recommends evaluating internalization of the collection services through the Parks and Recreation Department.

Pursuant to Section 2-173, Code of Ordinances of the City of Fort Lauderdale, Florida, these services are unique in nature and not readily subject to competition for the additional time period needed to complete the review and solicitation process and are

therefore deemed proprietary.

Resource Impact

There will be a fiscal impact to the City in the amount of \$149,602 \$108,078 per month, not to exceed \$648,468\$897.612, contingent upon approval of CAM 15-1312, Consolidated Budget Amendment. The fiscal impact represents the increased cost of the extension period, over the current contracted amount.
