Executive Airport Taxiway Sierra Pavement Rehabilitation Project - HDR

Engineering, Inc. – \$33,109 Task Order

### Recommendation

It is recommended that the City Commission approve a Task Order #7 (Exhibit 1) for construction services for the Fort Lauderdale Executive Airport Taxiway Sierra Pavement Rehabilitation Project with HDR Engineering, Inc. (HDR), in the amount of \$33,109.

# **Background**

Taxiway Sierra is an approximately 1,400 feet long by 50 feet wide stretch of pavement located north of Runway 27, at the Fort Lauderdale Executive Airport providing access to the airfield for several airport tenants. In 2012, the Florida Department of Transportation (FDOT) conducted a pavement evaluation at FXE. The evaluation determined that the pavement on Taxiway Sierra required milling and re-surfacing in order to extend its useful life.

In response to these findings, a design has been completed and a construction contract is anticipated to be awarded to General Asphalt Co. Inc. at the November 17, 2015 Commission Meeting (Related CAM #15-1278).

Staff has negotiated a task order for construction oversight with HDR to provide construction/engineering inspection and asphalt testing services in an amount not to exceed \$33,109. The scope of services includes, but is not limited to, attending weekly construction meetings, reviewing shop drawings, providing full-time inspection services, responding to requests for information and providing asphalt inspection services during paving operations. This task order is pursuant to the FXE General Engineering Aviation Consulting Services Agreement with HDR Engineering, Inc., approved by the City Commission on August 19, 2014 (CAM# 14-0924).

Funds for this task order are available from the project and from a Joint Participation

Agreement with the FDOT for the reimbursement of approximately 80% of the costs (\$26,487). Staff has reviewed both the task order and fees and found both to be acceptable. Approval of this task order is contingent upon approval of the construction contract.

### **Resource Impact**

There will be a fiscal impact to the City in the amount of \$33,109 for the task order.
