TITLE: Motion to Approve Contract for Delinquent Parking Citation Collection

Services - Penn Credit Corporation - \$90,000

#### Recommendation

It is recommended that the City Commission approve a contract for delinquent parking citation collection services with Penn Credit Corporation (Penn) utilizing the City of Tallahassee's contract number 3017, such agreement shall be coterminous with the City of Tallahassee's competitively bid contract.

## **Background**

On January 17, 2011, the City Commission awarded a two-year contract to Penn for primary placement of delinquent parking citation collection services. On August 11, 2014 an extension was granted that extended the contract to December 31, 2015.

Penn has quoted the City a fee of 16.5% of the amount collected on delinquent accounts. For delinquent accounts requiring legal action, the fee increases to 28% of the amount collected. The cost of the collection fees is added to the delinquent debt and charged to the debtor. Penn generated over \$490,000 in revenue collections for the City in FY 2015.

Pursuant to Section 2-181(7) Code of Ordinances of the City of Fort Lauderdale, Florida, this purchase will be made in accordance with the City of Tallahassee's contract number 3017 whereby such contract or formal bid followed formal bid procedures of sealed written bids, public opening, and legal advertising.

#### **Resource Impact**

There is a fiscal impact to the City in the estimated amount of \$90,000 in FY 2016. Any future expenditures are contingent upon approval of the City Commission.
