<u>SECTION 2.</u> That the scheduled July 5, 2016, Regular and Conference Meetings of the City Commission of the City of Fort Lauderdale, Florida, are hereby rescheduled to July 12, 2016, commencing at 1:30 p.m. Public hearings, ordinances, resolutions, and motions shall be heard commencing at 6:00 p.m. on July 12, 2016.

<u>SECTION 3.</u> That the scheduled September 6, 2016, Regular and Conference Meetings of the City Commission of the City of Fort Lauderdale, Florida, are hereby rescheduled to September 7, 2016, commencing at 1:30 p.m. Public hearings, ordinances, resolutions, and motions shall be heard commencing at 6:00 p.m. on September 7, 2016.

<u>SECTION 4.</u> That the scheduled October 4, 2016, Regular and Conference Meetings of the City Commission of the City of Fort Lauderdale, Florida, are hereby rescheduled to October 5, 2016, commencing at 1:30 p.m. Public hearings, ordinances, resolutions, and motions shall be heard commencing at 6:00 p.m. on October 5, 2016.

<u>SECTION 5.</u> That the City Clerk shall publish this resolution once in the official newspaper of the City at least three (3) days before January 19, 2016.

<u>SECTION 6.</u> That any resolution or part of a resolution in conflict herewith be, and is hereby rescinded to the extent of such conflict
