## CRA-2 15-1447 Motion to Execute a Fifth Amendment to Lease at 914 Sistrunk Boulevard (Sixth Street Plaza)

General Counsel Cynthia Everett noted this item was an extension of a lease agreement. Executive Director Feldman clarified that this was to get the City past the foreclosure hearing. Assistant City Attorney Lynn Solomon, gave an overview of the status of the foreclosure noting the Court lifted the automatic stay and delayed foreclosure sale until after November 15, 2015. The foreclosure sale is currently scheduled for Thursday, November 19, 2015, at 10:00 a.m. It was noted the owner never filed a bankruptcy plan.

Commissioner Trantalis asked Executive Director Feldman about the options available to the City from the mortgagee of the property, Regents Bank, and the option of purchasing this property out of foreclosure due to the fact the City has an investment in this property. He also questioned how this will influence future lease negotiations with a new purchaser.

City Auditor Herbst recommended the City Commission consider the City purchase the building it currently occupies for the amount of rent the City is committed to for the remainder of the lease. He stated if Regents Bank could consider this option, it will enable the City not to be out any additional monies, and the City would have ownership of the building at the end of the lease period. The Executive Director noted in his discussions with Regents Bank he did not feel the bank had an appetite to do this.

Discussion ensued among the Commission and other attendees on this topic.

Commissioner Roberts motioned to approve, and Commissioner Trantalis seconded this item.
