A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, PURSUANT SECTION 47-19.3.(e) OF THE CODE OF ORDINANCES OF THE CITY OF FORT LAUDERDALE GRANTING A WAIVER OF THE LIMITATIONS OF SECTION 47-19.3.(d) TO ALLOW ACQUE CELESTI, LLC C/O ROSE ANN LOVELL, TO CONSTRUCT AND MAINTAIN A 40' X 80' MARGINAL FLOATING DOCK, A 27 SQUARE FOOT FIXED DOCK, THE INSTALLATION OF SIX (6) TRIPLE PILE CLUSTERS AND TWO (2) MOORING PILES, EXTENDING FROM THE PROPERTY LINE A MAXIMUM DISTANCE OF 44.8 FEET AS TO THE TRIPLE PILE CLUSTERS AND A MAXIMUM DISTANCE OF 80.3 FEET AS TO THE MOORING PILES INTO MIDDLE RIVER, SUCH PROPERTY BEING LOCATED AT 900-910 NE 20TH AVENUE, FORT LAUDERDALE, FLORIDA, **PARTICULARLY** PROPERTY BEING MORE DESCRIBED BELOW; SUBJECT TO CERTAIN TERMS AND CONDITIONS; REPEALING ANY AND ALL PARTS OF RESOLUTIONS IN CONFLICT HEREWITH; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Acque Celesti, LLC, c/o Rose Ann Lovell, (hereinafter "Applicant") owns the following described Property located in the City of Fort Lauderdale, Broward County, Florida:

Lot 6, Block 1, of Gateway, According to the Plat thereof, as recorded in Plat Book 25, Page 24, Public Records of Broward County, Florida.

WHEREAS, Applicant is requesting approval for the construction and maintenance of a 40 x 8 marginal floating dock, a 27 square foot fixed dock, the installation of six (6) triple pile clusters and two (2) mooring piles extending from the property line a maximum distance of 44.8 feet as to the triple pile clusters and a maximum distance of 80.3 feet as to the

mooring piles into the Middle River; and

WHEREAS, the Property is located within the BI Boulevard Zoning District; and

WHEREAS, the City's Marine Advisory Board on November 16, 2015, reviewed the application for dock waiver filed by Applicant and voted to recommend approval of the dock waiver;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That pursuant to the provisions of ULDR Section 47-19.3.(e) of the Code of Ordinances of the City of Fort Lauderdale, the City Commission hereby grants a waiver of the limitations of the City's Unified Land Development Regulations ("ULDR") Section 47-19.3.(d), to allow Applicant to construct a 40 x 8 marginal floating dock, a 27 square foot fixed dock, the installation of six (6) triple pile clusters and two (2) mooring piles extending from the property line into the Middle River a maximum distance of 44.8 feet as to the triple pile clusters and a maximum of 80.3 feet as to the mooring piles, such distances being more specifically set forth in the Table of Distances set forth below:

<u>SECTION 2</u>. That the above waiver is subject to and contingent upon meeting the following additional conditions to be performed by the Applicant:

1. The Applicant is required to comply with all applicable building and zoning regulations as well as any other Federal and State laws and permitting requirements including the Broward County Environmental Protection and Growth Management Department, the Florida Department of Environmental Protection and the U.S. Army Corps of Engineers.

- 2. As a general condition of approval and in order to review for final consistency with construction of facilities in accord with this application and City building permits the Applicant is required to provide the City's Supervisor of Marine Facilities with copies of "As Built" drawings from a certified and licensed contractor and verification of all applicable Federal and State permits.
- 3. Use of the upland property and occupation thereof shall be in conformity with the City's ULDR and other applicable municipal, county, state and federal laws, rules, regulations and ordinances, including, but not limited to City Codes, and Unified Land Development Regulations, as same may be amended from time to time.
- 4. In accordance with City Code Sec. 8-149, repair and/or maintenance of vessels moored at this location shall be permitted only when such repair or maintenance is routine or minor in nature and does not involve major exterior alteration, rebuilding, complete refinishing, and/or removal of machinery, or the use of tools and equipment in such repair or maintenance which would be in violation of City Code of Ordinances, Chapter 17, Noise Control. Repair or maintenance, whether major or minor, shall be permitted in residential areas if such necessary work is conducted wholly within the confines of a permanent enclosed structure, and so long as the work complies with all other applicable City ordinances.
- Within ninety (90) days of adoption of this Resolution, Applicant shall file applications for permits for all other governmental or regulatory approvals required to implement the dock waiver herein and provide proof thereof to the Supervisor of Marine Facilities. In the event the Applicant fails to timely file applications for permits as referenced above, the granting of this waiver will expire, without prejudice to the Applicant re-filing a subsequent application for dock waivers.
- 6. The Applicant shall complete construction of the improvements as reflected in the application for the waiver of limitations through to a final certificate of completion no later than 180 days after adoption of this Resolution. In the event the Applicant fails to timely file applications for permits as referenced above, the granting of this waiver will expire, without prejudice to the Applicant re-filing a subsequent

application for dock waivers.

- 7. Violation of any of the foregoing conditions is unlawful and constitutes a violation of the City's ULDR and may result in revocation of this Resolution by the City Commission
- 8. In the event ownership of the Property is transferred to a third party prior to issuance of a building permit to construct the improvements authorized under this dock waiver Resolution, then this Resolution shall expire, without prejudice to the Applicant re-filing a subsequent application with the City for dock waivers.

<u>SECTION 3</u>. That all Resolutions or parts of Resolutions in conflict with this Resolution are hereby repealed.

<u>SECTION 4</u>. That a certified copy of this Resolution shall be recorded in the Public Records of Broward County, Florida at Applicant's expense and a copy of the recorded Resolution shall be filed with the Supervisor of Marine Facilities.

<u>SECTION 5</u>. That this Resolution shall be in full force and effect after its final passage and upon meeting all contingencies set forth above.
