TITLE: Motion to Approve Purchase of Lucas 2 Chest Compression Devices from
Physio-Control, Inc. - \$136,740.66

Recommendation

It is recommended that the City Commission approve the purchase of twelve Lucas 2 chest compression devices from Physio-Control, Inc. (Physio) in the amount of \$136,740.66.

Background

The Lucas chest compression system is a device that is used to deliver steady and consistent sternal compressions in cardiac arrest patients. The Lucas 2 model performs chest compressions far more efficiently and effectively than the most highly trained professionals. Equally important, the Lucas 2 device frees caregivers' hands so they can perform other life-saving interventions.

The Fire-Rescue Department currently has seventeen Lucas chest compression units in inventory. A majority of these units are approaching the end of their useful life and need to be replaced. Staff is requesting the purchase of twelve Lucas chest compression devices from Physio.

Pursuant to Section 2-181(8), Code of Ordinances of the City of Fort Lauderdale, Florida, the City may purchase items based on the terms of a contract let by an entity that is organized as a not for profit entity under its governing laws where the contract followed a fair and competitive process that included public notice; sealed, written or secure electronic bids; and public bid opening.

Pursuant to Section 287.012(11), Florida Statutes and Rule 60A-1.005, Florida Administrative Code, the City of Fort Lauderdale is authorized as an eligible user to access the National Association of State Procurement Officials Contract SW300 with the State of Oklahoma as the lead agency to acquire needed defibrillators and related equipment.

Resource Impact

There will be a fiscal impact to the City in the amount of \$136,740.66.
