Lessee currently pays a Minimum Base Rent of \$96,000.00 plus additional rent for: Real Estate Taxes - \$937.50; Water/Sewer/Trash from City -\$312.50; Insurance (Building & Liability) - \$281.25; In the event lease negotiations result in a lower rent structure, the Lessor and Lessee agree the Lessee shall be entitled to a mutually acceptable credit against future rent for excess rent paid by Lessee starting from September 1, 2015 through the date

of the new lease. In no event shall rent under the new lease exceed the current rent payment.

4. Unless modified herein, all other terms and conditions of the Lease, as amended, remain unchanged.
