**TITLE:** Motion to Approve Purchase of Toolcat Utility Work Machine – Clark  
Equipment Company dba Bobcat Company – \$64,267.58

---

**Recommendation**

It is recommended that the City Commission approve the purchase of one 2016 Bobcat Toolcat 5600 G-Series utility work machine via National Joint Powers Alliance (NJPA) Contract # 042815-CEC from Clark Equipment Company dba Bobcat Company (Bobcat) in the amount of \$64,267.58.

**Background**

The Fort Lauderdale Executive Airport (FXE) is responsible for ground landscape maintenance of approximately 328 acres which involves the airfield, an industrial park, and undeveloped out-parcels. Airfield grounds maintenance is critical in ensuring that vegetation height is maintained in accordance with Federal Aviation Administration standards for the safe operation of aircraft.

With the recent replacement of the 1998 New Holland tractor mower and sweeper with the 2015 John Deere Triple Flail tractor mower, FXE no longer has the ability to perform critical sweeping functions of runway and taxiway safety areas, and post-emergency debris removal. The requested Toolcat's sweeper attachment restores this capability and adds a utility vehicle to FXE's fleet that will be used daily for general maintenance and mowing functions. This vehicle was approved via a budget modification and is not replacing a vehicle currently in the fleet.

Pursuant to Section 2-181(7) Code of Ordinances of the City of Fort Lauderdale, Florida, this purchase will be made in accordance with NJPA Contract No. 042815-CEC from Bobcat in the amount of \$64,267.58, whereby such contract or formal bid followed formal bid procedures of sealed written bids, public opening, and legal advertising.

**Resource Impact**

There will be a fiscal impact to the City in the amount of \$64,267.58.
