PROFESSIONAL SERVICES

This Task Order is pursuant to the Agreement between the City of Fort Lauderdale, a Florida municipality, ("CITY") and Synalovski Romanik Saye, LLC, a Florida limited liability company, ("CONSULTANT"), for Architectural Consultant Services dated August 19th 2014, and expiring August 19th 2016 (collectively, "MASTER AGREEMENT").

PROJECT BACKGROUND

The Project is generally described as follows: ADA accessibility improvements to Fort Lauderdale's City Hall to ensure access to and within areas of the building. The project will include adequate accessible access ailes, crosswalks, and curb ramps from designated ADA parking spaces to the building. ADA unisex bathrooms on the 1st and 8th floor where public meetings are held and updated/improved ADA access to and within the Commission Chambers located on the 1st floor.

CONSULTANT services shall include the preparation of schematic design, construction documents, bidding/permitting assistance, and contract administration.

The CONSULTANT is responsible for working in cooperation with officials of the CITY, or it's designees, and with the CITY'S project managers in the design and construction of this project. The architectural design services include the preparation of plans and elevations; structural, mechanical, electrical, plumbing and construction administration required for the enclosed ramp from the City Hall 1st floor lobby to the Commission chambers. The CONSULTANT will be responsible for the preparation of all construction documents and will coordinate all required permit applications between the contractor and permitting agencies.

SPECIFIC SCOPE OF SERVICES

For convenience, the following formatting conventions are used in this Amendment:

- 1. Items from the original task order that are **deleted** by this Amendment are repeated and shown in **bold strikethrough font**.
- 2. Tasks that are not modified by this Amendment are not repeated.

Task 1 Design Development Services - The CONSULTANT shall research and select ADA stairlift,

The scope revisions/additions for this amendment are described below:

Task 5 ADA Access Ramp

The CONSULTANT shall provide professional services necessary to complete architectural and structural engineering services as required for the addition of an enclosed ADA accessible ramp from the south entrance of the 1st floor lobby to the Commission chambers. Services shall include the following:

- Construction documents
- Contract administration
- Architectural Services
- Structural Engineering and Mechanical, Electrical, and Plumbing design services

Deliverables:

Deliverables for this amendment shall be included as part of the original task order

PERFORMANCE SCHEDULE

The CONSULTANT shall perform the services identified in Tasks 5 by December 19th of 2015. The timeframe for project completion shall be included as part of the original task order.

METHOD OF COMPENSATION

The services performed will be accomplished using the Not-to-Exceed method of compensation. The total hourly rates payable by the CITY for each of CONSULTANT's employee categories, reimbursable expenses, if any, and sub-consultant fees, if any, are shown on Exhibit "A" attached hereto and made a part hereof. Pay applications shall be detailed and submitted monthly.


