

RESOLUTION NO. 16-33

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA, AUTHORIZING THE PROPER CITY OFFICIALS TO EXECUTE A HIGHWAY MAINTENANCE MEMORANDUM OF AGREEMENT WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION UNDER PROJECT FM NUMBER 432949-1 ALONG OLD DIXIE HIGHWAY BETWEEN NE 13TH STREET TO THE SOUTH END OF THE BRIDGE OVER THE OF THE MIDDLE RIVER AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in 2013, a final conceptual plan was agreed upon for Complete Streets Project improvements on Old Dixie Highway from NE 13th Street to the south end of the bridge over the Middle River in Broward County, Florida that included bike lanes, sidewalks, traffic calming including a traffic circle, landscaping, stormwater improvements and pedestrian lighting under FM No.: 432949-1(Project); and

WHEREAS, funding has been provided through the Broward Metropolitan Planning Organization and the Florida Department of Transportation (FDOT) to implement said Project; and

WHEREAS, Old Dixie Highway is a local street under the jurisdiction of the City of Fort Lauderdale; and

WHEREAS, the City of Fort Lauderdale ("City") and FDOT desire to execute a Highway Maintenance Memorandum of Agreement to maintain specific elements constructed under Project FM No.: 432949-1 according to a Highway Maintenance Memorandum of Agreement; and

WHEREAS, the City and FDOT desire to execute "Local Government Right of Way Certification Statement", indicating that the Project can be completed within the public right of way, and/or that no additional right of way is required; and

WHEREAS, in accordance with Federal Highway Administration regulations issued pursuant thereto, there must be an agreement from the City to maintain the Project prior to the Project being released for construction bid; and

WHEREAS, a Locally Funded Agreement between the City and FDOT will be executed on or about the same time as this Agreement;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF FORT LAUDERDALE, FLORIDA:

SECTION 1. That the proper City officials are hereby authorized to execute a Highway Maintenance Memorandum of Agreement between the City of Fort Lauderdale and the Florida Department of Transportation for the maintenance of Project improvements being installed on Old Dixie Highway between NE 13th Street to the south end of the bridge over the Middle River under FM No.: 432949-1.

SECTION 2. That the proper City Officials are hereby authorized to execute "Local Government Right of Way Certification Statement", indicating that the Project can be completed within the public right of way, and/or that no additional right of way is required.

SECTION 3. The office of the City Attorney shall review and approve as to form all documents prior to their execution by City officials.

SECTION 4. That this Resolution shall be in full force and effect upon final passage
